The Committee broadly supports the principles on which the Theft Offences Guideline is based, welcoming in particular the emphasis on placing the impact on victims of theft at the heart of the

sentencing process. The Sentencing Council should encourage sentencers to consider the use of Restorative Justice in the sentencing process in areas where it is available, while emphasising that it must always be victim-led and intended to benefit those who have been the subject of crime rather than the offender.
