In 1918 some draft projects of the League of Nations Covenant were elaborated by the Great Powers and the original texts demonstrate the initial absence of the matter, but as the brainstorming continued, the articles regarding the way to disarm appeared even more pregnant. The question at

stake concerned the reduction of armaments to the lowest point consistent with national defence and the fulfilment of international obligations, the abolition of the mandatory conscription, the prohibition to earn private profits from the manufacture of arms, the control of arms trafficking, and the 'full and frank' publicity of military programs. In 1919, during the Paris Peace Conference, motivated men worked to create an organization (forerunner of the United Nations) with the aim of avoiding future wars. In the final version of the Covenant some articles to realize Disarmament were present and a specific 'Commission' to carry on the related duties was established: the correspondence between the protagonists shows the difficulties in approaching the issue. They are also embedded in popular memories that periodically spark pride, shame, and resentment - whether over a rocky outcrop, a history textbook, or an alleged US intervention on a sensitive issue of national sovereignty. Everyday struggles for dignity and equality, the contributors argue, should not be overlooked in any search for explanations of nationalist pride and resentment. International Organizations play a pivotal role on the modern global stage and have done, this book argues, since the beginning of the 20th century. This volume offers the first historical exploration into the formative years of international public administrations, covering the birth of the League of Nations and the emergence of the second generation that still shape international politics today such as the UN, NATO and OECD. Centring on Europe, where the multilateralization of international relations played out more intensely in the mid-20th century than in other parts of the world, it demonstrates a broad range of historiographical and methodological approaches to institutions in international history. The book argues that after several 'turns' (cultural, linguistic, material, transnational), international history is now better equipped to restate its core questions of policy and power with a view to their institutional dimensions. Making use of new approaches in the field, this book develops an understanding of the specific powers and roles of IO-administrations by delving into their institutional make-up.
